- 1. That Outlot C hereby released from the Declaration and is no longer subject to any of its terms or provisions.
- 2. That MCWD and Declarant (and all subsequent owners of Outlot C) shall have no further obligations or rights under the Declaration with regard to Outlot C.
- 3. Except as specifically amended by this instrument, the Declaration shall otherwise remain in full force and effect.
